

THE RIGHTS AND THE OBLIGATIONS OF THE (ORGANIZER), ELIDA Co '94

- Is obliged to apply the articles of this Application (signed).
- Is obliged to place at disposal of the Applicant the area and the requested services according to the Application Form, signed.
- To provide guardian services from 20.00 to 09.30.
- To provide rule and normality during the time that the Fair is opened.
- The timetable of the visitors will be from 10.00 to 20.00.
- To provide the general cleaning.
- The division of the stands will be under the responsibility of the Organizer, which reserves to himself the right to change the place and the dimensions of the stands, determined by the Applicant in the Application for Participation, in case of the special technical and organisational needs.
- The Organizer provides the entrance - ticket The Applicant to get in and out the goods from the environments of the Fair after he has paid off all the payments of the participation in the fair.
- In case that The Applicant doesn't pay off the payments, The Organizer reserves the right of the blockade of the goods (Of The Applicant) as a guaranty for the total payment for the participation in the Fair.

THE RIGHTS AND THE OBLIGATIONS OF THE APPLICANT

- Is obliged to apply the "Application for Participation".
- Is obliged to make the payment according to the Application.
- To take the inventory of the stand and the equipment (as: spotlights, chairs, table etc.), that ELIDA Co '94 places at disposal of the Applicant and to deliver that in the end of the fair. For every damage The Applicant is obliged to pay the Organizer.
- The Applicant has the right to develop his activity and publicity only inside his stand and in the height of 2.5 ml. The Organizer uses the spaces over this height.
- He hasn't the right to let in his stand another subject that is out of this contract, in the contrary when this is verified the Applicant is penalized with 3 - folds of the value signed in this Application.
- The Applicant responds for every damage caused in the floor, wall or stand.
- The Applicant is obliged to apply the timetable.
- The representative of the company is obliged to deliver the stand to the guard service at the end of the day in the presence of the guardian; in the contrary the organizer doesn't have responsibility for any losses or damages.
- The goods have to be taken out not later than one day after the closing of the Fair, in the contrary the organizer doesn't have responsibility for them.

THE TEMPORARY CUSTOMS REGIME

- The foreign participant submits the Temporary Customs Regime for the goods that they present in the Fair, according to the law that is in force in the Republic of Albania. ELIDA Co '94 authorizes a customs agency for the fulfilling of the procedures for the Temporary Regime. In case that the participant doesn't make the arrangements with the determined agency, the organizer doesn't take the responsibility for applying the Temporary Regime for him.

THE RESPONSABILITIES OF THE PARTIES

- The Organizer (ELIDA Co 94) takes the responsibility and returns the sum to The Applicant only in the cases when the activity doesn't take place for the reasons that are consequence of the actions or not actions of the Organizer.
- The Applicant takes the responsibility when he doesn't apply the contract and cancels it in the one - side manner.
- The parties don't have responsibility when the violations are as a consequence of the major forces such as: earthquakes, wars, fire, overflows, the extraordinary measures determined by the Government etc.

THE CANCELLATION OF THE APPLICATION

- The contract is terminated at the end of Fair's duration.

Before the end of the Fair it can be cancelled:

- For the cases when the parties don't respect the terms of this contract.
- In the agreement between the parties.
- When the lodger doesn't use the object for the intention that he has taken it and changes its destination.
- When the lodger leases the pavilion.

THE SOLUTION OF MISUNDERSTANDING

- The misunderstandings between the parties are going to be solved by understanding, in the contrary they have to be addressed to the District Court of Tirana. The legal base is the articles of the Civil Code and this contract.

This contract will be in force with the signature from the parties and it is valid after the payment of the 50 % of the value, by the Organizer.
